File Layouts for GIFTS BTR

Introduction

PC Business Banking allows an electronic bank statement to be delivered to your desktop as regularly as you would like. The transaction information downloaded during this process can be exported into a Tab Separated or ASCII text file to a destination of your choice or it can be printed. To run an automatic update from this process is therefore difficult without a human interface.

PC Business Banking will also allow the delivery of electronic transaction information in the GIFTS (comma delimited) format. Therefore allowing greater ease for this information to be integrated into an account systems.

File Record Limitations and Restrictions for GIFTS

Two files are delivered on a daily basis in the GIFTS format and will be delivered to the directory specified in PC Business Banking. The files contain balance information (*.BAL) and transaction information (*.TRN). Two other files are available on request. The files contain fluctuation information (*.FLU) and profile information (*.PRF). The files are in ASCII format, with each field being separated by a comma and specific fields containing the data within quotation marks ("") eg:

3,205482,"02-573-0015170-00",-123.45,Serial Number,015,"Particulars","Code", "Reference","OP Name","dd-mm-yy"

Each record is terminated with a Carriage Return Line Feed combination. The file naming convention is as follows:

YYMMDD.???

Where

YYMMDD = today's date. The file will contain yesterday's information

??? = file extension eg. TRN for transaction information

Transaction Record

Transaction records contain a record type identification digit to describe the type of data contained within the record. The record type precedes the data eg. The transaction record above contains a '3' at the beginning of the record as an identification digit.

Details of the contents of the transaction records can be supplied by the Bank eg. transaction codes, Bank/Branch numbers, account suffix descriptions etc.

Account Profiles and Fluctuations - (available upon request)

Account Profiles contain general account information eg. accrued interest, debit and credit interest rates etc. Account Fluctuations contain the highest and lowest balances for each month if available.

Account Number Structure

Account numbers are shown in the following format:

BB-bbbb-nnnnnn-ss

BB - Bank Number. Each bank has a unique two digit Bank Number eg. '02' indicated Bank of New Zealand.

bbbb = Branch Number. Each branch for each bank has a unique 4 digit Branch Number eg. 0500 indicates the Bank of New Zealand Wellington Branch.

nnnnnn = Account Number. Basic account numbers contain a high order zero and six digits, they are always zero filled.

ss = Suffix. Within the basic account number, customers can maintain a range of suffixes. Different suffixes have varying attributes eg. 00-29 are cheque accounts, 81 is a term investment, 91 is a term loan. A basic account number and suffix make up one account number eg. 0015170-00 is a cheque account for a customer.

A full list of Bank and Branch numbers is available from the Bank.

File Layout

Balance File Format

The balance file contains a single record for each account loaded. Amount fields are zero filled in balance or total transactions is zero. This record is in the following format:

- 8 Account Total Record (for each account suffix)
- 9 Account Total Record (for all accounts in the download)
